Medical

A two-part health form is enclosed. The Personal Health and Medical Record is to be completed by the parent/guardian and Medical Evaluation portion is to be completed by a physician in its entirety. All inoculations must be current. Refer to the Medical Record form for details. Any medications prescribed for your child and any special instructions concerning the health of your child should be left with the Camp Health Lodge Staff at the time of registration.

Camp Fee

The park is within a two or three-hour drive from Harrisburg, Philadelphia, and New York City and one hour from Allentown, Scranton and Wilkes-Barre.


New York/New Jersey Metropolitan Area
